What Are The Requirements?

- Applications are available on the City's website and by contacting the City Clerk's office. Applications must be completed, signed and forwarded to the City Clerk's office.
- Completed applications are distributed to the Mayor and City Council and can be filed at any time of the year as a vacancy occurs.
- Apply for no more than three boards. If you apply for more than one, please indicate order of preference.
- Appointments are made by the Mayor and City Council generally in December of each year.
- Members may serve only on one (1) advisory board or commission at a time.
- Members of advisory boards and commissions serve without compensation unless otherwise provided.
- Members must reside inside City limits but there are some exceptions (*i.e. Utilities Commission and Tourism Authority have designated members who may reside outside City limits due to special qualifications.*)
- Members may serve on the same board for no more than two consecutive terms, without an intervening period of three years.
- Appointments shall be made up of persons of commitment and prestige, representing a cross section of the community including racial, religious, business, labor and civic elements.
- Accommodations to participate in meetings are provided to all board and commission members, as well as the general public (*i.e. hearing impairments*).
